Locations & Travel Prices quoted are for locations in the Eastbourne, Hailsham and Seaford areas, additional time and/or mileage may be charged for other areas. The Photographer 5. On occasions and without notice it may be necessary for the photographer originally specified to be substituted by another photographer, (e.g.. due to ill health). 6. All image sizes are nominal. The photographer/s will provide a pleasing colour balance but cannot guarantee exact colour matching owing to anomalous reflectance caused by a combination of certain dyes and materials especially man-made fibres. 18. Complaints
